The Engineering Department request use of Public Space on behalf of Ms. Janet Anderson, property owner of 40 West Cayuga Street, located in the Third Ward, for eight foot by fourteen foot (8'x14') for landscaping and a new tree between the curb and sidewalk; fronting West Cayuga Street. The Engineering Department request use of Public Space on behalf of Mr. Robert Molinari, property owner of a single-family dwelling at 199 ½ Liberty Street, located in the Fifth Ward, for eleven foot by twenty-five foot (11'x25') for a new paved one (1) car parking area between the curb and sidewalk; fronting Liberty Street. They are requesting use of the Veteran's Stage & Oswego Riverwalk West, road closures, and a waiver from the noise ordinance and vender fees as applicable. The Parade would begin at Breitbeck Park on Lake Street and turn onto West First Street and ending at the Flexo Wire Site, and is requesting the appropriate road closures for safety.

Justin Rudgick, Community Development Director, received a request from Michael Lavner with the Oswego YMCA regarding the Skate the Banks event to be held on Saturday, August 19, 2017 from 2 pm to 7 pm at West 2nd Street in the pathfinder Bank Parking Lot. They are requesting a partial road closure on West Second Street in proximity of the Pathfinder Bank Parking Lot.
