Mitigation shall consist of replacing the tree with a tree or trees of equal size or total diameter inches at four feet from the ground either on the parcel from which the tree was removed or at another mutually agreed-upon location. C. Donations and requests to plant privately donated trees in public space shall be considered by the Common Council and processed through the appropriate ward Councilor. The Tree Advisory Board shall be consulted to consider tree type, size and potential pest problems.
