

**ADMINISTRATIVE SERVICES
COMMITTEE MEETING
February 3, 2020**

Chairman Corradino called the meeting to order at 6:30 p.m. in the 2nd floor Common Council Chambers of City Hall.

MEMBERS PRESENT: Councilor Corradino, Councilor Burridge, Councilor Hill, Councilor Tesoriero, Councilor McBrearty.

OTHERS PRESENT: Councilor Walker; Councilor Gosek; William J. Barlow, Jr., Mayor; Kevin Caraccioli, City Attorney.

MEDIA PRESENT: Steve Yablonski, Oswego Daily News; Matthew Reitz, Palladium Times; Randy Pellis, Oswego Shopper.

A motion to approve the minutes of January 21, 2020 meeting was made by Councilor Tesoriero and seconded by Councilor McBrearty; minutes were approved by a unanimous vote.

OLD BUSINESS: There was no old business.

NEW BUSINESS:

Mayor William J. Barlow, Jr. has received a request from David Thompson, Owner of Gibby's Irish Pub, located at 8 West Second Street, to obtain a strip of property adjacent to 8 West Second Street. Kevin Caraccioli said that this was originally discussed with the Council last year and since then he has obtained more information and a professionally done survey from Mr. Thompson. He said this entails an 8 foot by 85 foot strip of property. He said the plans include extending the current building. He said that Jeff McGann confirmed that this extension did not encroach on the sidewalk. He said that as far back as July Mr. Thompson has sought this purchase and he is asking for a purchase price of \$1. He said there are plans to put significant investments into the building. Councilor Corradino asked if Mr. Thompson also owns the one-story house (33 West Van Buren Street) also pictured on the map. Kevin Caraccioli said that yes he does, so the lot measures 50 feet by 85 feet. Jeff McGann said that Mr. Thompson has begun the process to merge those two properties. Councilor Tesoriero asked if Councilor McBrearty is comfortable with this proposal. Councilor McBrearty said that yes she is comfortable with the proposal.

COMMITTEE DECISION: Councilor Hill made a motion to forward a favorable recommendation to the Full Council to authorize the request from David Thompson Owner of Gibby's Irish Pub, located at 8 West Second Street, to obtain a strip of property adjacent to 8 West Second Street. Councilor Burrige seconded the motion, and was unanimously approved.

THE MAYOR'S OFFICE WILL PREPARE THE RESOLUTION.

A motion to adjourn the meeting was made at 6:36 p.m. by Councilor Tesoriero. A second was made by Councilor McBrearty, and was unanimously approved.
