

**PHYSICAL SERVICES
COMMITTEE MEETING
October 1, 2018**

Chairman Hill called the meeting to order at 6:55 p.m. in the 2nd floor Common Council Chambers of City Hall.

MEMBERS PRESENT: Councilor Hill, Councilor Wilmott, and Councilor Gosek.

OTHERS PRESENT: Councilor Corradino; Councilor Tesoriero; Councilor McBrearty; Tory DeCaire, Police Chief; Kevin Caraccioli, City Attorney; Deborah Coad, City Chamberlain; Tom Kells, Commissioner of Public Works; and Justin Rudgick, Director of Community & Economic Development.

A motion to approve the minutes of September 17, 2018 was made by Councilor Gosek and seconded by Councilor Wilmott; minutes were approved by a unanimous vote.

I. OLD BUSINESS: There was no old business.

II. NEW BUSINESS:

Authorization:

1. The Engineering Department submitted a request on behalf of Daniel Batchelor, owner of a single-family dwelling located at 149 West Eighth Street, for a four foot (4') high gate between the sidewalk and property line fronting West Eighth Street. Councilor Hill said it is a small gate between two bushes. He said he recommends approval.

COMMITTEE DECISION: Councilor Wilmott made a motion to forward a favorable recommendation to the Full Council granting Daniel Batchelor, owner of a single-family dwelling located at 149 West Eighth Street, use of public space for a four foot (4') high gate between the sidewalk and property line fronting West Eighth Street. Councilor Gosek seconded the motion, unanimous approval.

2. The Engineering Department submitted a request on behalf of Michael Belden, owner of a single-family dwelling at 169 East Sixth Street located in the Fourth Ward, for proposed use of public space seven foot by thirteen foot (7'x13") for a new covered porch wood deck with pergola between the sidewalk and right-of-way fronting East Sixth Street. Councilor Wilmott said Mr. Belden has a porch on the front of his house now.

He said he is going to tear that off and go the whole width of the house. He said he is going to extend it another foot deeper. He said he fully supports this.
