**Authorization:**

1. The Office of Economic Development received a request from Buc Boosters regarding the Buc Spirit 5K event to be held on Saturday, September 29, 2018 at 9:00 am. The event is not requesting road closures but would like a Police Escort to start the race as well as throughout the course. Justin Rudgick said he checked with Chief DeCaire and the police are fine with providing the police escort for the event. Councilor DeMassi questioned if they would be using someone on duty. Justin Rudgick said when he submits the requests to OPD they just let him know if they can provide that or not.

He said they are looking to do an event at Veteran's Stage to celebrate one year of being in business and to recognize the success they have had with Taco Tuesday. He said they have had 85 different people during that ride. He said during a six week period they had rides that went from 26 to 31 participants. He said they wanted to recognize the people that have participated.
